You or Buyer are also responsible to provide your own material handling equipment and packing supplies. Buyer must provide Auctioneer with an executed Agent Release Authorization and you must provide Auctioneer with a Certificate of Insurance (as set forth below) before you will be allowed on the auction site. You must provide the paid invoice at time of pickup. In the event purchased merchandise contains any environmental hazards, toxic waste or other type of hazardous material in any form whatsoever, Buyer or you shall provide evidence prior to pick up that the party removing the assets is licensed for such removal and will comply with all applicable local, state and/or federal rules, laws and regulations. You agree that Auctioneer, its agents or representatives will not be responsible for containment, storage or removal of any such hazardous material and expressly release any claim against Auctioneer, its agents or representatives with regard to any such hazardous material.

In the event an item is unavailable at the time of pick-up, you or Buyer must immediately notify Auctioneer's site representative, as well as send an email notification to Auctioneer within 24 hours. Auctioneer shall not be responsible for claims made once items are removed from the auction premises.

Failure to Remove Purchases. In the event items are not removed in the timeframes allotted, the items purchased shall be deemed abandoned and Buyer will lose any right, title or interest you may have acquired and the items shall revert and repossess to us without further notice to you.

Removal of Installed Items. In the event the sale involves the removal of installed Items, Buyer is responsible for and entitled to remove the item as described to first point of utility disconnect only. Buyer has acknowledged (and you acknowledge) that you should not assume Buyer is entitled to any controls, in wall wiring, cables, connectors or down line components, unless specifically stated so in the lot description. In the event the removal of an item results in damage to the sale site and/or the creation of trash and debris on or around the sale site, you and Buyer shall be responsible for associated repair and clean up of the sale site. This includes, but is not limited to, patching of an exterior wall or roof to reasonable standards when the removal of the item results in a hole.

You hereby agree to indemnify, hold harmless and defend Auctioneer and its respective agents, representative or employees from and against any and all losses, damages, liabilities and claims, including attorney fees, costs and expenses arising out of based upon or resulting from: (1) failure to secure all safety equipment and to meet all applicable government safety standards in removing items purchased or used by Buyer, (2) failure to comply with safety instructions issued from Auctioneer, (3) the claim of any third party claiming or challenging title to any items purchased or claiming infringement of any proprietary interest, and (4) any injury to Auctioneer or any other person or property of any type whatsoever caused during the dismantling, removing or transporting of items purchased by Buyer.
